RULE REMINDER

Residents are encouraged to promote good neighbourliness by engaging, where possible, with other residents in a non-confrontational manner. As such the rules on good neighbourliness are also there to guide self-regulation by the community. We would like to remind residents of the following rules:

54. Building material, building rubble, topsoil, **garden refuse**, rocks and similar items **may not be stored or dumped on the sidewalks or other open spaces.** If this rule is breached by a Resident, his/her household, visitors, service providers or contractors, the maximum penalty allowed in terms of the Penalty Schedule will be levied against the Resident. In addition, the SHOA may remove the rubble and recover the costs of such removal from the responsible Resident.

SHOA 4-BALL AT THE ICC

Southdowns Residents are able to book a daily golf four-ball, subject to availability. Please note however that bookings need to be made through the SHOA offices. This benefit is free with the exception of Saturdays which will incur playing fees at the applicable members or discounted visitors playing fee rates. Due to the exception of Saturday bookings, 2 four-balls can be booked on Mondays, Tuesdays and Thursdays. Golf carts can be booked when available to be charged out at members rates. Bookings will only be accepted from residents who are members of the club with a valid member's card. Member Cards can be collected from the ICC offices during office hours.

UPDATE: OWNERSHIP OF RESIDENTIAL GAS SUPPLY

SHOA management team is happy to inform our Residents that after fulfilment of the conditions precedent and governance requirements, the Southdowns Homeowners Association is now in control of its own gas reticulation. This follows the resolution passed at two Special General Meetings the Gas reticulation by the estate will be with effect from 1 April 2023 and to receive the benefit of the net price reduction in the gas price which will commence effective 1 May 2023, in time for winter.

The board is grateful that this legacy will benefit the Residents of Southdowns, present and future.

The HOA will provide for the continuity of our supply contingencies in the new gas price based on actuarial calculations and scenarios to ensure that adequate provision is made for maintenance and augmentation should it ever become necessary.

With immediate effect, the HOA staff will take over the gas meter-reading function to ensure a smooth transition and capturing of the consumption data. Residents may recall that, apart from securing the future supply of our own gas reticulation, management is also currently working on a water reservoir solution to mitigate the possibility of prolonged water interruptions such as were recently experienced in the greater Gauteng region.

The members of the SHOA Board express their gratitude for the overwhelming support it received for the gas business transfer and to SMS who have efficiently managed the business from the inception of the development of the estate.

At the two Special General Meetings of the Southdowns Homeowners, it was resolved that Southdowns Homeowners Association (NPC) would purchase the Gas Supply business from Southdowns Management Services (Pty)Ltd.

We are pleased to inform you that the transaction has been concluded and that the Residential Gas Supply agreement between yourself and Southdowns Management Services (Pty)Ltd has now been ceded (In terms of clause 14.2) to the Southdowns Homeowners Association, with effect from 1 April 2023. The Gas Supply Agreement remains unchanged, other than the SHOA has taken over from SMS as the Gas Reticulator.

We thank you for your support over the past few years and are confident that the SHOA will maintain the service levels you have come to expect.

3.Ticket Stats


The majority of the tickets were logged due to residents being offline due to something that was resolved in the resident's homes.
